# 1. MINUTES - Annette Perot

The minutes from the Combined Meeting of December 12, 2012 were attached to the agenda for review. A motion was made by Kathy Chaika and seconded by Kathy McEachron to approve the minutes as amended. The motion carried with 10 attendees voting "aye", and 3 abstaining.

# 2. TREASURER'S REPORT - Linda Herda

The report of accounting activity and ending balances for December 2012 were attached to the agenda for review. Checking account ending balance: \$9,411.05, Savings account ending balance: \$10,943.74 with 46¢ interest earned. The year-to-date interest earned was \$6.18. Linda announced the audit needs to be done in February. There is 1 volunteer auditor, 1 more needs to be recruited. Linda will begin work on the End of the Year report to submit to CSEA that is due at the end of February.

# 3. CHAPTER BUDGET - Annette Perot

The proposed Chapter 33 Budget for 2013 was attached for review. A discussion on changes to the original budget as well as including two new line items (joining San Mateo Labor Council and Scholarships) followed. A motion to approve the budget as amended was made by Kathy Chaika and seconded by Charles Jones. The motion carried with 16 approve, 1 opposed.
